Market Lake Day: Clerk: We have food and merchant vendors. 650 N from 2872 E to 2880 E will be closed off this year instead of 2880 E from 650 N to 657 N.

Discussion - Mustang Event Center Disposition: Discussion regarding what to do with the Mustang Event Center (MEC). Mayor Berlin was given a ballpark estimate for demolition of \$200,000. Fixing the building to be used would be more. There was also discussion regarding whether to surplus the building and the cost of maintenance if the building is repaired.

Update - Roberts Community Center Project: Clerk said that the building will need to be tested for radon as part of the environmental study for the Community Block Development Grant (CBDG).

Discussion and Vote - Architect Contract for Roberts Community Center Project: Meyers Anderson presented Council with a contract for the Roberts Community Center Project. The project will include HVAC, bathroom remodeling for ADA compliance, ADA exterior doors, and ADA ramp. The total sum of the contract is to be 10% of the construction costs. The \$3000 the city has already paid before the CBDG grant was awarded will be credited to the overall fees.
