### Mayor's Report:

Constitution Week: Mayor Berlin proclaimed September 17-23, 2025, as Constitution Week.

Market Lake Day: Mayor Berlin said that we received positive feedback with this year's setup. He thanked everyone who helped make this year's Market Lake Day a success.

Discussion and Vote - Sheriff's Contract: Council was presented with the 2025-2026 Law Enforcement contract. Mayor Berlin said there were no changes in the amount of wording of from the previous contract. The contract was reviewed by the city attorney, he had- no issues with the contract.

Discussion - November 11, 2025 Meeting Date Change: Council reminded that the November meeting is on November 10 due to Veteran's Day.

Update - Roberts Community Center Project: Clerk said that the environmental study has been completed and approved. There is a meeting next Tuesday to go over the drawings from Myer

Anderson (architect firm) and discuss scheduling. The city has done some small improvement projects at the RCC, such as some landscaping. The projects do count as in-kind for the grant.

Update - Mustang Park Improvement Project: Taci Stoddard with Altura Community Consulting said that the basketball/pickleball court has been completed. Warranty work was completed by Knife River, replacing a portion of the sidewalk that had cracked. The project will be closed out, and the final bill for Altura's services will be invoiced. The City held a ribbon-cutting on August 12 at 6:30 pm.

Update - Wastewater Project: Ribbon Cutting is scheduled for Friday, October 10, 2025, at 1 p.m. The city will be inviting Congressman Mike Simpson and/or a representative. Jaden Jackson, engineer, Keller Associates, said that the project is completed except for a few minor issues. The fence is installed. Edstrums will be placing two concrete blocks around the electrical stub to prevent it from being hit. The meter box at Lucy's had to be updated so Rocky Mountain Power would energize the building. Taci said that there is a hearing scheduled for August 26, 2025 at 6:20 pm for the Community Development Block Grant (CDBG) funding.

Update - Child Pedestrian Sidewalk: Jaden said that the Child Pedestrian project has started and paving should begin next Tuesday. JM Concrete said that they plan on completing the sidewalk by the time they pave.

**Update – Water Facility Improvement Project:** Jaden said that Keller is has approximately sixty percent (60%) complete. It is projected that the building will be out for bid around December/January. Taci said that Altura will apply for a CDBG for the city for this project

#### Maintenance Report:

Mayor Berlin: Candidates for the additional maintenance position have been interviewed. Mayor Berlin will make a decision by next week. The new water and wastewater operators have started, and the Mountain West Environmental contract will end on August 14, 2025. The transition seems to be going smoothly. The new operators have been taking the tests for the facilities. The mayor of Rigby has approved our wastewater e-coli tests be done in their lab, saving the city money on testing.

Ron Grant: Wastewater infrastructure was finished. Bushes were pulled and trimmed at city hall. Sod was put in at the library and Mustang Park restroom. Milling are being spread for parking at Mustang Park. Rick is watering, mowing, at the parks and weed-eating around town. Department of Environmental Quality (DEQ) completed an inspection of the wastewater plant. The city has contracted Western States to maintain the city's generators. The shop is being cleaned and reorganized. A meter pit riser was installed at the sidewalk project.
