

ORDINANCE NO. 137

AN ORDINANCE PROVIDING THAT ALL BY-LAWS, ORDINANCES, AND RESOLUTIONS OF THE CITY OF ROBERTS, IDAHO, LAWFULLY PASSED AND IN FORCE AT THE TIME THE VILLAGE OF ROBERTS, IDAHO, BECAME A CITY UNDER THE PROVISIONS OF HOUSE BILL NO. 3, AS AMENDED, BY THE 39th SESSION OF THE LEGISLATURE OF THE STATE OF IDAHO, SHALL REMAIN IN FULL FORCE AND EFFECT UNTIL ALTERED OR REPEALED BY THE MAYOR AND COUNCIL OF SUCH CITY; AND THAT THE PASSAGE OF SAID HOUSE BILL NO. 3, AS AMENDED, SHALL NOT IMPAIR OR AFFECT ANY ACT DONE, OFFENSE COMMITTED OR RIGHT ACCRUING, ACCRUED, OR ACQUIRED, OR LIABILITY, PENALTY, FORFEITURE OR PUNISHMENT INCURRED PRIOR TO THE EFFECTIVE DATE OF SUCH LEGISLATIVE ACT AND THE SAME MAY BE ENJOYED, ASSETED, ENFORCED, PROSECUTED OR INFLICTED AS FULLY AND TO THE SAME EXTENT AS IF SUCH ACT HAD NOT BEEN PASSED.

WHEREAS, House Bill No. 3, as amended, of the 39th Session of the Legislature of the State of Idaho, which took effect the 12th day of April, 1967, provides that all villages theretofore incorporated under the general laws of this State and theretofore operating with a Board of Trustees shall thereafter operate with a Mayor and Council under the provisions of such bill; and

WHEREAS, pursuant to said House Bill No. 3, as amended, the City of Roberts has duly reorganized the persons constituting the former Board of Trustees of the Village of Roberts, Idaho into a City Council and has duly chosen a Mayor of the City of Roberts.

Now, therefore, be it ordained by the Mayor and Council of the City of Roberts, Jefferson County, Idaho, as follows:

Section 1. All by-laws, ordinances, and resolutions lawfully passed and in force in the City of Roberts, Idaho, under its former organization as the Village of Roberts, Idaho, shall remain in full force and effect until altered or repealed by the Mayor and Council of the said City of Roberts.

Section 2. The passage of House Bill No. 3, as amended, by the 39th session of the Legislature of the State of Idaho, which took effect the 12th day of April, 1967, shall not impair or effect any act done, offense committed or right accruing, accrued or acquired or liability, penalty, forfeiture or punishment incurred prior to the effective date of such Legislative act but the same may be enjoyed, asseted, enforced, prosecuted or inflicted as fully and to the same extent as if such act had not been passed.

The persons constituting the Board of Trustees of the Village of Roberts, Jefferson County, Idaho, met, pursuant to the provisions of House Bill No. 3, as amended, by the Thirty-Ninth Session of the Legislature of the State of Idaho, for the purpose of organizing as the Mayor and Council of the City of Roberts, Jefferson County, Idaho, on October 19, 1967 at the regular meeting place in the City Hall in the City of Roberts, Idaho, at 8:00 p.m. o'clock. All persons constituting the Board of Trustees of the Village of Roberts were present to wit:

Harold Larson, Chairman
Sheldon Stoker, Trustee
Charles French, Trustee
Ray Jackson, Trustee
Dick Furrows, Trustee

Harold Larson presided as acting President of the Council and appointed Reed L. Berrett to act as temporary City Clerk and to record the minutes of the meeting. After each member of the Council had subscribed to the oath of office, the acting President of the Council announced that the first item of business was the election of the President of the Council. Thereupon, pursuant to motion made by Ray Jackson, seconded by Charles French, and unanimously carried by the four members of the Council, Harold Larson was elected President of the Council to serve until the persons elected at the next succeeding general City election shall have been elected and qualified. Said Harold Larson then took the chair. The President of the Council then announced that there was a vacancy in the office of Mayor of the City of Roberts and pursuant to motion made by Ray Jackson, and seconded by Charles French and unanimously carried by the four members of the Council, Harold Larson was elected Mayor of the City of Roberts to serve until the person elected as Mayor at the general city election to be held on November 7, 1967 shall have been elected and qualified. Harold Larson then took the chair as Mayor.

The Mayor then recommended the following persons to serve as City Clerk, City Treasurer, and City Attorney, respectively:
